Our teams use a comprehensive approach to improving energy efficiency in residential properties. We begin by improving SAP by following the most cost effective fabric first approach such as installing cavity wall, internal solid wall & loft insulation, to boost heat retention in low-income households. If households are eligible for the appropriate funding, we then assess and install larger upgrades including boiler replacements, heat pumps, solar panels, and first-time central heating systems.

We aim to install multiple measures that will yield significant improvements in SAP ratings. Incorporating smarter heating controls and guidance resources is vital to our approach. Combined with energy-saving measures, these elements enable customers to manage their energy use more effectively, thereby reducing energy usage and carbon emmissions. WARM HOMES:

SOCIAL HOUSING FUND

Formley known as the SHDF Wave 3, the Warm Homes: Social Housing Fund aims to allocate funding to local authoties, combined authorities registered charities and social housing pr oviders.

WARM HOMES: LCOAL GRANT FUND

Local authorities can apply for funding via the government's new Warm Homes: Local Grant scheme which facilitates energy performance improvements and installation of lowcarbon measures in low-income privately owned or rented households in England with EPC ratings between D and G.

SUBSTANTIAL FUNDING

Access to £M's in annual government funding, coordinated directly with local authorities and major energy providers.

ENERGY COMPANYOBLIGATION SCHEME

The government-funded Energy Company Obligation Scheme (ECO) aims to increase energy efficiency and overall heat rentention in lower-income households by installing state-of-the-art heating and insulation measures, resulting in lower energy bills.

GREAT BRITISHINSULATION SCHEME

The Great British Insulation Scheme was designed to compliment ECO4 by offering single insulation measures rather than the ECO4 'whole house' approach. It is aimed at low-income households with an EPC rating of D-G or within A-D Countil Tax bands.

HEAT NEWTWORK ENERGY SCHEME

Households in England and Wales can apply for a grant that covers some of the cost of replacing fossil fuel heating systems (such as oil, gas, electric and LPG) with boimass boilers or heat pumps.







ELIGIBILITY CRITERIA:

- Properties with an EPC rating of E-G (or no EPC).
- Tenants receiving government benefits, earning below £31,000 annually, or with specific health conditions.
- Properties must be tenant-occupied, habitable, and privately owned. Trusted Guarantee: Trustmark-accredited measures* with up to a 25-year guarantee.
